[CV-25-425](#). Thomas Crockett v. Dexter Payne, Director, Arkansas Division of Correction, from Jefferson County Circuit Court. Appellant's pro se motion to file belated reply brief. Affirmed; motion moot. Special Justice Mary Carole Young joins. Bronni, J., not participating.

CV-26-243. Dave Campbell and Dawn Campbell v. James Turnbough and Melissa Rogers, from Fulton County Circuit Court. Petitioners' pro se emergency petition for writs of prohibition, mandamus, and certiorari; and emergency motion for stay of proceedings; and petitioners' pro se emergency motion for stay of proceedings pending disposition of petition for extraordinary writs.
