#### **FINDINGS OF FACT**

- 1. Tom Anderson filed with the Public Employment Relations Commission a petition concerning representation of employees of the Glenwood School District. The petition was timely filed and accompanied by a showing of interest administratively determined by the Commission to be sufficient.
- 2. The Glenwood Education Association/Washington Education Association is the incumbent labor organization that represented the petitioned-for employees and was granted status as intervenor in these proceedings.
- 3. These representation proceedings were conducted under the supervision of the Commission in the bargaining unit described as:

All certificated teachers employed by the Glenwood School District, excluding supervisors, confidential employees, classified employees, and all other employees.

4. All proceedings were conducted in a manner designed to afford the affected employees a free choice in the selection of their bargaining representative, if any; a tally of the results previously furnished to the parties is attached hereto; and no meritorious objections have been filed with respect to these proceedings.

#### CONCLUSIONS OF LAW

- 1. The unit described in Finding of Fact 3 is an appropriate unit for the purpose of collective bargaining within the meaning of RCW 41.59.080.
- 2. All conditions precedent to a certification have been met.
